The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase :  
將會使用何種方法，決定有意購買該等指明住宅物業的每名人士可揀選其意欲購買的住宅物業的優先次序：

First come first served provided that only person(s) who is/are (i) all HKPR or (ii) one or more of the purchasers is/are HKPR and the remaining purchaser(s) is/are not HKPR but is/are his/her close relative (i.e. in relation to individual, means a spouse, parent, child, brother or sister of the individual) shall be eligible to purchase the specified residential properties. Persons interested in purchasing any of the specified residential properties must :-

- (a) personally attend the ifc Venue; and
- (b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s). The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by such person(s). Each cashier order shall be in the sum of HK\$100,000 and made payable to “MAYER BROWN JSM”.

If the purchaser(s) has(ve) successfully selected any of the specified residential properties, he/she shall **personally** enter into a Preliminary Agreement for Sale and Purchase of the specified residential property(ies) successfully selected by him/her. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies).

For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the ifc Venue before the commencement time of sale.

In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting).  
The Vendor reserves the right to close the ifc Venue at any time if all the specified residential properties have been sold out.

If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 10:00 a.m. and 8:00 p.m. on any date of sale, then, for the safety of the persons interested in purchasing the specified residential properties and the maintenance of order at the ifc Venue, the Vendor reserves its absolute right to postpone the date of sale to such other date(s) and/or time as the Vendor may consider appropriate and/or to close the ifc Venue. Details of the arrangement will be posted by the Vendor on the website (www.thewings3a.com) designated by the Vendor for the Development.

以先到先得形式發售，惟只有(i)所有買家均為香港永久性居民或(ii)其中一位或多於一位買家為香港永久性居民而餘下的買家並非香港永久性居民但為其近親（就任何個人而言，指其即配偶、父母、子女、兄弟或姊妹）才有資格購買該等指明住宅物業。有意購買該等指明住宅物業的每名人士須遵從下列程序：
