The maximum second mortgage loan amount shall be 20% of the net purchase price, but the total amount of first mortgage loan and second mortgage loan offered shall not exceed 85% of the net purchase price, or the balance of purchase price payable, whichever is lower. The Purchaser shall apply to the Vendor in writing for the HK\$5,000 Cash Rebate at least 30 days before the date of settlement of balance of purchase price or the estimated material date for the development as specified in the agreement for sale and purchase (whichever is earlier). After the Vendor has received

the application and duly verified the information, the Vendor will apply the HK\$5,000 Cash Rebate for part payment of the balance of the purchase price directly.

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.

This loan is subject to other terms and conditions.

The First 3 Years Maintenance Offer is subject to other terms and conditions.

For the avoidance of doubt, for each purchase of a residential property, the Purchaser is only entitled to either enjoy the Relaxing-Purchase Price Discount or

apply for the First 24 Months Payment Holiday Second Mortgage Loan as set out in paragraph (4)(C5)(iii)2. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

Any gift, or any financial advantage or benefit, to be made available in connection with the purchase of a specified residential property in the development

The Purchaser shall apply to the Vendor in writing (accompanied with the **official receipt(s)** for payment of all stamp duty payable on the agreement for sale and purchase) for the Stamp Duty Cash Rebate at least 30 days before the date of settlement of the balance of the purchase price or the estimated material date for the development as specified in the agreement for sale and purchase (whichever is earlier). After the Vendor has received the application and duly verified the information, the Vendor will apply the Stamp Duty Cash Rebate for part payment of the balance of the purchase price directly.

Where the preliminary agreement for sale and purchase is signed on or before 31 October 2014, the Purchaser may apply for a Transitional Loan (the "Transitional Loan") from the designated financing company.

The Purchaser shall make the application for the Transitional Loan at the same time as the signing of the preliminary agreement for sale and purchase.

The final interest rate will be subject to approval by the designated financing company.

Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate (if any) as set out in paragraph (4)(C5)(iii)1(a).

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.

For the avoidance of doubt, for each purchase of a residential property, the Purchaser is only entitled to either enjoy the Relaxing-Purchase Price Discount as set out in paragraph (4)(C5)(ii)3 or apply for the First 24 Months Payment Holiday Second Mortgage Loan. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

This loan is subject to other terms and conditions.

After the Vendor has received the application and duly verified the information, the Vendor will apply the 3% Cash Rebate for part payment of the balance of the purchase price directly.

為免疑問，買方只可選擇使用首24個月免息免供第二按揭貸款或3%現金回贈。買方須為於同一份臨時買賣合約下購買的所有住宅物業選擇相同之優惠。

For the avoidance of doubt, the Purchaser can only choose either to utilize the First 24 Months Payment Holiday Second Mortgage Loan or to obtain the 3% Cash Rebate. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

The Purchaser of the residential property marked with “#” or “##” in the price list can exercise his/her option to purchase residential car parking space(s) in accordance with time limit and manner as prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor.

The First 3 Years Maintenance Offer is subject to other terms and conditions.

If the Purchaser does not choose the Home Purchase Price Discount as set out in paragraph (4)(D5)(ii)2 upon the signing of preliminary agreement for sale and purchase, the Purchaser will be offered the following Stamp Duty Offer(s):

Upon signing of the agreement for sale and purchase (unless otherwise agreed by the Vendor), the Purchaser shall deposit with the Vendor’s solicitors the amount of ad valorem stamp duty on the agreement for sale and purchase (including the fixed fee for stamping a counterpart of the agreement for sale and purchase) and (where required by the Stamp Duty Ordinance) the preliminary agreement for sale and purchase; and (if applicable) the amount of buyer’s stamp duty, for the Vendor’s solicitors to arrange for the agreement for sale and purchase and (where required by the Stamp Duty Ordinance) the preliminary agreement for sale and purchase to be stamped by the Collector of Stamp Revenue within the time limit prescribed by the Stamp Duty Ordinance.

The Purchaser shall apply to the Vendor in writing (accompanied with the **official receipt(s)** for payment of all stamp duty payable on the agreement for sale and purchase) for the Stamp Duty Cash Rebate at least 30 days before the date of settlement of the balance of the purchase price or the estimated material date for the development as specified in the agreement for sale and purchase (whichever is earlier). After the Vendor has received the application and duly verified the information, the Vendor will apply the Stamp Duty Cash Rebate for part payment of the balance of the purchase price directly.

After the Vendor has paid the amount of Stamp Duty Cash Rebate, then even if the amount of the stamp duty actually payable exceeds the amount of the Stamp Duty Cash Rebate paid by the Vendor, the Vendor is not required to pay any other or additional Stamp Duty Cash Rebate to the Purchaser. In case of dispute, the Vendor reserves the right on the determination of the amount of the Stamp Duty Cash Rebate, and such determination shall be final and binding on the Purchaser.

The Stamp Duty Cash Rebate is subject to other terms and conditions.

Transitional Loan - Stamp Duty Payment (Applicable only to the Purchaser who is individual or limited company incorporated in Hong Kong with all its shareholder(s) and director(s) being individual(s))

- (I) 凡於 2014 年10月31 日或之前簽署臨時買賣合約，買方可向指定財務機構申請過渡性貸款(『過渡性貸款』)。
Where the preliminary agreement for sale and purchase is signed on or before 31 October 2014, the Purchaser may apply for a Transitional Loan (the “Transitional Loan”) from the designated financing company.
- (II) 買方須於簽署臨時買賣合約時同時申請過渡性貸款。
The Purchaser shall make the application for the Transitional Loan at the same time as the signing of the preliminary agreement for sale and purchase.

The Transitional Loan amount is equal to the total amount of 70% of ad valorem stamp duty and (if applicable) 70% of buyer’s stamp duty.

The maturity date of the Transitional Loan is the date of settlement of the balance of the purchase price in accordance with the agreement for sale and purchase.
- (V) 利率以香港上海匯豐銀行有限公司之港元最優惠利率加2% p.a.計算，利率浮動。如買方在到期日或之前準時還清過渡性貸款，**將獲豁免貸款利息**。
Interest rate shall be Hong Kong Dollar Best Lending Rate quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited plus 2% p.a. (subject to fluctuation). If the Purchaser shall duly repay the Transitional Loan on or before the maturity date, **interest on the Transitional Loan will be waived.**
- (VI) 所有過渡性貸款的法律文件需由賣方代表律師準備及安排簽署。如買方另行自聘律師作為其代表律師處理過渡性貸款，買方須負責其代表律師有關費用及雜費。
All legal documents of the Transitional Loan shall be prepared by and arranged for signing by the Vendor’s solicitors. If the Purchaser shall instruct his/her own solicitors to act for him/her for the Transitional Loan, the Purchaser shall bear his/her own solicitors’ relevant costs and disbursements.
- (VII) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。
The Purchaser is advised to enquire with the designated financing company about the purpose and details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.
- (VIII) 此貸款受其他條款及細則約束。
This loan is subject to other terms and conditions.

If the Purchaser does not utilize the Transitional Loan and has settled the balance of the purchase price in accordance with the agreement for sale and purchase, an extra cash rebate of HK\$5,000 for each residential property (“HK\$5,000 Cash Rebate”) would be offered to the Purchaser.

買方須於付清樓價餘額之日或買賣合約內訂明的發展項目的預計關鍵日期(以較早者為準)前最少30日，以書面向賣方申請港幣\$5,000現金回贈，賣方會於收到申請並確認有關資料無誤後將港幣\$5,000現金回贈直接用於支付部份樓價餘額。

The Purchaser shall apply to the Vendor in writing for the HK\$5,000 Cash Rebate at least 30 days before the date of settlement of balance of purchase price or the estimated material date for the development as specified in the agreement for sale and purchase (whichever is earlier). After the Vendor has received the application and duly verified the information, the Vendor will apply the HK\$5,000 Cash Rebate for part payment of the balance of the purchase price

directly.

The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

After the Vendor has received the application and duly verified the information, the Vendor will apply the Early Settlement Cash Rebate for part payment of the balance of the purchase price directly.

The date of settlement of the purchase price shall be the date on which all the purchase price is received by the Vendor's solicitors. The final interest rate will be subject to approval by the designated financing company.

The maximum second mortgage loan amount shall be 25% of the net purchase price, but the total amount of first mortgage loan and second mortgage loan offered shall not exceed 80% of the net purchase price, or the balance of purchase price payable, whichever is lower. Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate (if any) as set out in paragraph (4)(D5)(iii)1(a) and the Early Settlement Cash Rebate (if any) as set out in paragraph (4)(D5)(iii)2.
- (d) 第二按揭貸款年期最長為20年，或第一按揭貸款之年期，以較短者為準。
The maximum tenor of second mortgage loan shall be 20 years or the tenor of first mortgage loan, whichever is shorter.

The Purchaser shall provide sufficient documents to prove his/her/its repayment ability, including but not limited to providing sufficient documents to prove that the total amount of monthly instalment (being the total instalment for repayment of first mortgage loan, second mortgage loan and any other loan repayment) does not exceed 50% of the aggregate total monthly income of the Purchaser and his/her/its guarantor(s) (if any).

First mortgage loan and second mortgage loan shall be approved by the relevant mortgagees independently.

All legal documents of second mortgage shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her own solicitors' costs and disbursements relating to the second mortgage.
- (i) 買方需就申請第二按揭貸款支付港幣\$5,000不可退還的申請手續費。
The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.
- (j) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。
The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.
- (k) 為免疑問，申請備用第二按揭貸款之買方，不可申請第(4)(D5)(iii)4段之180換樓易貸款。
For the avoidance of doubt, a Purchaser who applies for the Standby Second Mortgage Loan cannot apply for the 180 Bridging Loan as set out in paragraph (4)(D5)(iii)4.

- (l) 此貸款受其他條款及細則約束。

This loan is subject to other terms and conditions.

4. 180 換樓易貸款(只適用於個人名義買方) (“180 換樓易貸款”)

180 Bridging Loan (Applicable only to the Purchaser who is individual(s)) (“180 Bridging Loan”)

買方可向賣方的指定財務機構(『指定財務機構』)申請 180 換樓易貸款，主要條款如下：

The Purchaser can apply to the Vendor’s designated financing company (“designated financing company”) for the 180 Bridging Loan. Key terms are as follows:

- (a) 買方必須於買賣合約內訂明的發展項目的預計關鍵日期前最少60日以書面方式向指定財務機構申請180換樓易貸款。

The Purchaser shall make a written application to the designated financing company for the 180 Bridging Loan not less than 60 days before the estimated material date for the development as specified in the agreement for sale and purchase.

Interest rate for the 180 Bridging Loan shall be one month HIBOR plus 2.25% p.a. or Hong Kong Dollar Best Lending Rate quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited (“Hong Kong Dollar Best Lending Rate”) minus 2.25% p.a., whichever is lower (subject to fluctuation). Interest shall be payable monthly. One month HIBOR rate shall be quoted by the designated financing company from time to time (subject for fluctuation). The final interest rate will be subject to approval by the designated financing company.

The principal of the 180 Bridging Loan shall be repaid by one lump sum at the maturity date.

All legal documents of 180 Bridging Loan shall be handled by the Vendor’s solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her/their own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her/their own solicitors’ costs and disbursements relating to the 180 Bridging Loan.

The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the 180 Bridging Loan.

The 180 Bridging Loan shall be secured by a first legal mortgage over the residential property.

- (k) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.

If the Purchaser does not utilize the 180 Bridging Loan and has settled the balance of the purchase price in accordance with the agreement for sale and purchase, an extra cash rebate of HK\$10,000 for each residential property (“HK\$10,000 Cash Rebate”) would be offered to the Purchaser.

買方須於買賣合約內訂明的發展項目的預計關鍵日期前最少30日，以書面向賣方申請港幣\$10,000現金回贈，賣方會於收到申請並確認有關資料無誤後將港幣\$10,000現金回贈直接用於支付部份樓價餘額。

The Purchaser shall apply to the Vendor in writing for the HK\$10,000 Cash Rebate at least 30 days before the estimated material date for the development as specified in the agreement for sale and purchase. After the Vendor has received the application and duly verified the information, the Vendor will apply the HK\$10,000 Cash Rebate for part payment of the balance of the purchase price directly.

為免疑問，買方只可選擇使用180換樓易貸款或港幣\$10,000現金回贈。買方須為於同一份臨時買賣合約下購買的所有住宅物業選擇相同之優惠。

For the avoidance of doubt, the Purchaser can only choose either to utilize the 180 Bridging Loan or to obtain the HK\$10,000 Cash Rebate. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

5. 住戶停車位優惠

Offer of Residential Car Parking Space(s)

- (a) 選購於價單上設有符號“#”之住宅物業之買方，可享有認購發展項目的一個住戶停車位的權利。

The Purchaser of a residential property that is marked with a “#” in the price list is entitled to have an option to purchase one residential car parking space.

選購於價單上設有符號“##”之住宅物業之買方，可享有認購發展項目的最多兩個住戶停車位的權利。

The Purchaser of a residential property that is marked with a “##” in the price list is entitled to have an option to purchase up to a maximum of TWO residential car parking space(s).

購買於價單上設有符號“#”或“##”之住宅物業的買方可根據賣方日後公佈的住戶停車位之銷售安排所規定的時限及方法行使其認購住戶停車位的權利。

The Purchaser of the residential property marked with “#” or “##” in the price list can exercise his/her option to purchase residential car parking space(s) in accordance with time limit and manner as prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor.

- (b) 如買方不根據賣方日後公佈的住戶停車位之銷售安排行使其認購住戶停車位的權利，其認購住戶停車位的權利將會自動失效，買方不會為此獲得任何補償。
If the Purchaser does not exercise the option to purchase residential car parking space(s) in accordance with time limit and manner prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor, the option to purchase residential car parking space(s) shall lapse automatically and the Purchaser shall not be entitled to any compensation therefor.

The maximum second mortgage loan amount shall be 25% of the net purchase price, but the total amount of first mortgage loan and second mortgage loan offered shall not exceed 80% of the net purchase price, or the balance of purchase price payable, whichever is lower. Net purchase price means the amount of the purchase price of the residential property after deducting the Stamp Duty Cash Rebate (if any) as set out in paragraph (4)(E5)(iii)1(a) and the Early Settlement Cash Rebate (if any) as set out in paragraph (4)(E5)(iii)2.
- (d) 第二按揭貸款年期最長為20年，或第一按揭貸款之年期，以較短者為準。
The maximum tenor of second mortgage loan shall be 20 years or the tenor of first mortgage loan, whichever is shorter.
- (e) 買方須提供足夠文件證明其還款能力，包括但不限於提供足夠文件證明每月還款(即第一按揭貸款加第二按揭貸款及其他借貸的還款)不超過買方及其擔保人(如有)的每月總入息之一半。
The Purchaser shall provide sufficient documents to prove his/her/its repayment ability, including but not limited to providing sufficient documents to prove that the total amount of monthly instalment (being the total instalment for repayment of first mortgage loan, second mortgage loan and any other loan repayment) does not exceed 50% of the aggregate total monthly income of the Purchaser and his/her/its guarantor(s) (if any).
- (f) 第一按揭銀行須為指定財務機構所指定及轉介之銀行，買方並且須首先得到該銀行同意辦理第二按揭貸款。
First mortgagee bank shall be nominated and referred by the designated financing company and the Purchaser shall obtain a prior consent from the first mortgagee bank to apply for a second mortgage loan.
- (g) 第一按揭貸款及第二按揭貸款申請需由有關承按機構獨立審批。
First mortgage loan and second mortgage loan shall be approved by the relevant mortgagees independently.
- (h) 所有第二按揭法律文件需由賣方代表律師辦理，並由買方負責有關律師費用及雜費。買方可選擇另行自聘律師作為買方代表律師，在此情況下，買方亦須負責其代表律師有關第二按揭的律師費用及雜費。
All legal documents of second mortgage shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her own solicitors' costs and disbursements relating to the second mortgage.
- (i) 買方需就申請第二按揭貸款支付港幣\$5,000不可退還的申請手續費。
The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the second mortgage loan.

- (j) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.

- (k) 為免疑問，申請備用第二按揭貸款之買方，不可申請第(4)(E5)(iii)4段之180換樓易貸款。

For the avoidance of doubt, a Purchaser who applies for the Standby Second Mortgage Loan cannot apply for the 180 Bridging Loan as set out in paragraph (4)(E5)(iii)4.

- (l) 此貸款受其他條款及細則約束。

This loan is subject to other terms and conditions.

4. 180換樓易貸款(只適用於個人名義買方) (“180換樓易貸款”)

180 Bridging Loan (Applicable only to the Purchaser who is individual(s)) (“180 Bridging Loan”)

買方可向賣方的指定財務機構(『指定財務機構』)申請180換樓易貸款，主要條款如下：

The Purchaser can apply to the Vendor's designated financing company (“designated financing company”) for the 180 Bridging Loan. Key terms are as follows:

- (a) 買方必須於買賣合約內訂明的發展項目的預計關鍵日期前最少60日以書面方式向指定財務機構申請180換樓易貸款。

The Purchaser shall make a written application to the designated financing company for the 180 Bridging Loan not less than 60 days before the estimated material date for the development as specified in the agreement for sale and purchase.

- (b) 180換樓易貸款之利率為1個月香港銀行同業拆息加2.25% p.a.或香港上海滙豐銀行有限公司不時報價之港元最優惠利率(『港元最優惠利率』)減2.25% p.a.，以較低者為準，利率浮動。利息須每月支付。1個月香港銀行同業拆息須為指定財務機構不時之報價，利率浮動。最終按揭利率以指定財務機構審批結果而定。

Interest rate for the 180 Bridging Loan shall be one month HIBOR plus 2.25% p.a. or Hong Kong Dollar Best Lending Rate quoted from time to time by The Hongkong and Shanghai Banking Corporation Limited (“Hong Kong Dollar Best Lending Rate”) minus 2.25% p.a., whichever is lower (subject to fluctuation). Interest shall be payable monthly. One month HIBOR rate shall be quoted by the designated financing company from time to time (subject for fluctuation). The final interest rate will be subject to approval by the designated financing company.

- (c) 180換樓易貸款之貸款本金金額於貸款到期日一次性歸還。

The principal of the 180 Bridging Loan shall be repaid by one lump sum at the maturity date.

- (d) 180換樓易貸款期限為180日。

The tenor of 180 Bridging Loan shall be 180 days.

- (e) 180換樓易貸款最高金額為樓價的70%，或應繳付之樓價餘額，以較低者為準。

The maximum 180 Bridging Loan amount shall be 70% of the purchase price or the balance of purchase price payable, whichever is lower.

- (f) 買方須提供足夠文件證明其還款能力。

The Purchaser shall provide sufficient documents to prove his/her/their repayment ability.

- (g) 所有180換樓易貸款法律文件需由賣方代表律師辦理，並由買方負責有關律師費用及雜費。買方可選擇另行自聘律師作為買方代表律師，在此情況下，買方亦須負責其代表律師有關180換樓易貸款的律師費用及雜費。

All legal documents of 180 Bridging Loan shall be handled by the Vendor's solicitors and all the costs and disbursements relating thereto shall be borne by the Purchaser. The Purchaser can choose to instruct his/her/their own solicitors to act for him/her, and in such event, the Purchaser shall also bear his/her/their own solicitors' costs and disbursements relating to the 180 Bridging Loan.

- (h) 買方需就申請180換樓易貸款支付港幣\$5,000不可退還的申請手續費。

The Purchaser shall pay HK\$5,000 being the non-refundable application fee for the 180 Bridging Loan.

- (i) 180換樓易貸款以該住宅物業之第一法定按揭作抵押。

The 180 Bridging Loan shall be secured by a first legal mortgage over the residential property.

- (k) 買方敬請向指定財務機構查詢有關貸款用途及詳情。貸款批出與否及其條款，指定財務機構有最終決定權。不論貸款獲批與否，買方仍須按買賣合約完成住宅物業的交易及繳付住宅物業的樓價全數。

The Purchaser is advised to enquire with the designated financing company about the purpose and the details of the loan. The approval or disapproval of the loan and the terms thereof are subject to the final decision of the designated financing company. Irrespective of whether the loan is granted or not, the Purchaser shall complete the purchase of the residential property and shall pay the full purchase price of the residential property in accordance with the agreement for sale and purchase.

- (l) 為免疑問，申請第(4)(E5)(iii)2 段之提前付清樓價現金回贈及/或(4)(E5)(iii)3段之備用第二按揭貸款之買方，不可申請180換樓易貸款。

For the avoidance of doubt, a Purchaser who applies for the Early Settlement Cash Rebate as set out in paragraph (4)(E5)(iii)2 and/or the Standby Second Mortgage Loan as set out in paragraph (4)(E5)(iii)3 cannot apply for the 180 Bridging Loan.

- (m) 此貸款受其他條款及細則約束。

This loan is subject to other terms and conditions.

如買方最終沒有使用180換樓易貸款及已按買賣合約付清樓價餘額後，可就每個住宅物業獲額外港幣\$10,000現金回贈(『港幣\$10,000現金回贈』)。

If the Purchaser does not utilize the 180 Bridging Loan and has settled the balance of the purchase price in accordance with the agreement for sale and purchase, an extra cash rebate of HK\$10,000 for each residential property (“HK\$10,000 Cash Rebate”) would be offered to the Purchaser.

買方須於買賣合約內訂明的發展項目的預計關鍵日期前最少30日，以書面向賣方申請港幣\$10,000現金回贈，賣方會於收到申請並確認有關資料無誤後將港幣\$10,000現金回贈直接用於支付部份樓價餘額。

The Purchaser shall apply to the Vendor in writing for the HK\$10,000 Cash Rebate at least 30 days before the estimated material date for the development as specified in the agreement for sale and purchase. After the Vendor has received the application and duly verified the information, the Vendor will apply the HK\$10,000 Cash Rebate for part payment of the balance of the purchase price directly.

為免疑問，買方只可選擇使用180換樓易貸款或港幣\$10,000現金回贈。買方須為於同一份臨時買賣合約下購買的所有住宅物業選擇相同之優惠。

For the avoidance of doubt, the Purchaser can only choose either to utilize the 180 Bridging Loan or to obtain the HK\$10,000 Cash Rebate. The Purchaser must choose the same offer for all the residential properties purchased under the same preliminary agreement for sale and purchase.

5. 住戶停車位優惠

Offer of Residential Car Parking Space(s)

- (a) 選購於價單上設有符號“#”之住宅物業之買方，可享有認購發展項目的一個住戶停車位的權利。

The Purchaser of a residential property that is marked with a “#” in the price list is entitled to have an option to purchase one residential car parking space.

選購於價單上設有符號“##”之住宅物業之買方，可享有認購發展項目的最多兩個住戶停車位的權利。

The Purchaser of a residential property that is marked with a “##” in the price list is entitled to have an option to purchase up to a maximum of TWO residential car parking space(s).

購買於價單上設有符號“#”或“##”之住宅物業的買方可根據賣方日後公佈的住戶停車位之銷售安排所規定的時限及方法行使其認購住戶停車位的權利。

The Purchaser of the residential property marked with “#” or “##” in the price list can exercise his/her option to purchase residential car parking space(s) in accordance with time limit and manner as prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor.

- (b) 如買方不根據賣方日後公佈的住戶停車位之銷售安排行使其認購住戶停車位的權利，其認購住戶停車位的權利將會自動失效，買方不會為此獲得任何補償。

If the Purchaser does not exercise the option to purchase residential car parking space(s) in accordance with time limit and manner prescribed by the sales arrangement of the residential car parking spaces to be announced by the Vendor, the option to purchase residential car parking space(s) shall lapse automatically and the Purchaser shall not be entitled to any compensation therefor.

- (c) 住戶停車位的售價及銷售安排詳情將由賣方全權及絕對酌情決定，並容後公佈。

The price and sales arrangement details of residential car parking spaces will be determined by the Vendor at its sole and absolute discretion and will be announced later.

6. 首 3 年保養優惠

First 3 Years Maintenance Offer

在不影響買方於買賣合約下之權利的前提下，凡住宅物業有欠妥之處，而該欠妥之處並非由任何人之行為或疏忽造成，買方可於發展項目的滿意紙或轉讓同意書發出日(以較早者計)起計 3 年內向賣方發出書面通知，賣方須在收到書面通知後在合理地切實可行的範圍內盡快自費作出修補。首 3 年保養優惠受其他條款及細則約束。Without affecting the Purchaser's rights under the agreement for sale and purchase, the Vendor shall at its own cost and as soon as reasonably practicable after receipt of a written notice served by the Purchaser within 3 years from the date of issuance of the certificate of compliance or consent to assign in respect of the development, (whichever is earlier), rectify any defects to the residential property caused otherwise than by the act or neglect of any person. The First 3 Years Maintenance Offer is subject to other terms and conditions.

If the Purchaser appoints the Vendor's solicitors to act on his/her behalf in the agreement for sale and purchase and the assignment in relation to the purchase, the Vendor agrees to bear the legal cost of the agreement for sale and purchase and the assignment.
2. 如買方選擇另聘代表律師為買方之代表律師處理其買賣合約及轉讓契，買賣雙方須各自負責有關買賣合約及轉讓契兩項法律文件之律師費用。
If the Purchaser chooses to instruct his/her own solicitors to act for him/her in relation to the agreement for sale and purchase and the assignment, each of the Vendor and the Purchaser shall pay his/her own solicitors' legal fees in respect of the agreement for sale and purchase and the assignment.
3. 買方須支付一概有關臨時買賣合約、買賣合約及轉讓契之印花稅(包括但不限於任何買方提名書或轉售的印花稅、任何從價印花稅、額外印花稅、買家印花稅及任何與過期繳付任何印花稅有關的罰款、利息及附加費用)。
All stamp duty on the preliminary agreement for sale and purchase, the agreement for sale and purchase and the assignment (including without limitation any stamp duty on any nomination or sub-sale, any ad valorem stamp duty, special stamp duty, buyer's stamp duty and any penalty, interest and surcharge, etc. for late payment of any stamp duty) will be borne by the Purchaser.

(v) 買方須為就買賣該項目中的指明住宅物業簽立任何文件而支付的費用

Any charges that are payable by a purchaser for execution of any document in relation to the sale and purchase of a specified residential property in the development.

製作、登記及完成公契及管理協議(『公契』)之費用及附於公契之圖則費用的適當分攤、所購物業的業權契據及文件認證副本之費用、所購物業的買賣合約及轉讓契之圖則費、為申請豁免買家印花稅或從價印花稅新稅率而須的任何法定聲明的費用、所購住宅的按揭(如有)之法律及其他費用及代墊付費用及其他有關所購物業的買賣的文件的所有法律及其他實際支出，均由買方負責。



The Purchaser shall bear and pay a due proportion of the costs for the preparation, registration and completion of the Deed of Mutual Covenant and Management Agreement (the “DMC”) and the plans attached to the DMC, all costs for preparing certified copies of title deeds and documents of the property purchased, all plan fees for plans to be annexed to the agreement for sale and purchase and the assignment of the property purchased, the costs of any statutory declaration required for application for exemption of buyer’s stamp duty and/or new rates of ad valorem stamp duty, all legal and other costs and disbursements in respect of any mortgage (if any) in respect of the property purchased and all legal costs and charges of any other documents relating to the sale and purchase of the property purchased.
